Procedures followed in respect to new members follows:-

1. A prospective New Member is permitted to attend the Range three (3) times as a "Visitor".
2. The Applicant is then required to complete an Application Form for Membership and pay the application fee and subscription fee.
3. After a probationary period (approximately 10 attendances during which he/she must attend the Range for safety courses and competitions), the Committee may grant him/her full membership, extend his/her probationary period or reject him/her as unsuitable.
4. If granted full membership, the Member is then entitled to all Members' benefits. Fees are refunded if application is not approved.
5. Membership period is from the 1st of January to 31st of December. It is the responsibility of the member to make sure that their membership does not lapse. Firearms Headquarters is notified of the Club's membership status annually. Any firearms of non-financial members licensed for Club use "A" will be cancelled accordingly.
6. Pro-rata membership fee is limited to a maximum discount of fifty percent (50%).

NOTE:

Purpose "A" Firearm licenses are issued exclusively to financial members of the Club. All Members with firearms licensed for Club Use "A" are obliged to participate in 75% of competitions and activities held by the Club within the year to retain their firearm licence in compliance with the PNG Firearms Act. Non-compliance of the attendance requirement without any valid notification to the Committee will automatically disqualify the member from holding a firearm license and will result in the automatic cancellation of your Firearm Licence and the confiscation of your Firearm. All applications for "A" Purpose License must be accompanied with a Club Firearm License Endorsement.

Upon submission of the **completed form** and **prescribed payment** to the Club, the applicant becomes a **Probationary Member**.

A Probationary Member shall be entitled to all Club facilities **except** recommendation to the Police for a firearm license. Once a Probationary Member successfully completes his/her firearm safety training (ten sessions), the committee shall consider his/her application for full membership.

A Probationary Member whose membership is not approved shall be entitled to a full refund of membership and joining fee.
